Payment Plans

Every family is required to select a tuition payment plan at the time of enrollment/ re-enrollment. There are 3 payment plan options. The payment plan includes Tuition, Campus Improvement and Security Fee, and Book /Class Fee in equal installments consistent with the payment plan selected. All payment plans include the nonrefundable tuition installment.

Beginning on June 1 st , 12 monthly installments based on the Total Annual Cost will be due which include Annual Tuition and Fixed fees.	One full payment due on June 1 st . A 5% discount on tuition will be applied for payments made by the due date via ACH or check. Discount is not applicable if paid by credit card.	Two total payments due at 50% of total per semester. Fall semester due June 1 st . Spring Semester due December 1 st . A 2.5% discount on tuition will be applied per semester for payments made by the due dates via ACH or check. Discount is not applicable if paid by credit card.

Multiple Child Discount

Tuition is assessed at the full rate for the oldest student attending Florida Christian School from the same family (household). A multiple child discount is granted to offset tuition for each additional sibling enrolled living in the same household at the following rates:

10% discount – 2nd student

20% discount – 3rd student

30% discount – 4th student

Regardless of the payment plan selected, non-refundable fees are as follows:

Campus Improvement and Security Fee \$750 (non-refundable)

The Campus Improvement and Security Fee of \$750 is due from each family (household) at the time of enrollment. The Campus Improvement and Security Fee may be paid over installments consistent with the payment plan selected. Regardless of payment plan selected, the non-refundable Campus Improvement and Security Fee is due in full to FCS.

Book / Class Fee

Book / Class Fee (Kindergarten – Elementary) and Class Fee (6th to 12th grade) is due for each student at the time of Enrollment. The Book/Class Fee may be paid over installments consistent with the payment plan selected, at the rates stated below:

The cost for textbooks and workbooks that are consumed by our pre-school students are included in the monthly tuition payments. Regardless of payment plan selected, the non-refundable book/ class fee is due in full to FCS.

Kindergarten and elementary students will be assessed a book fee between \$225 and \$425, respectively, for all textbooks and workbooks provided by the school.

Secondary students (grades 6-12) must purchase textbooks and workbooks from FOLLETT.com and ABeka books from the FCS bookstore. Other books not available at Classbook.com can be purchased from the FCS bookstore. Classbook.com will conduct a book buy-back at the end of the school year. Only books which will be used by the school the following year and have not been written in or damaged, will qualify for the book buyback program. E textbooks will be available for various books used in our curriculum. Parents will have the option of purchasing available texts in the electronic format.

Withdrawal – Dismissal

Withdrawals from school must be requested through the online withdrawal form on the website. A Withdrawal Form must be signed by the financially responsible parent or legal guardian.

After careful consideration, a student may be dismissed when he or she is found out of harmony with the regulations and policies of the school or for excessive demerits. Excessive demerits include receiving: fifty (50) demerits during a grading period, or forty (40) demerits during two consecutive grading periods, or sixty (60) demerits during a school year.

Students must turn in all school issued equipment, team uniforms, library books, etc., on his/her last day of attending school. All accounts must be cleared (no past-due balance) for records to be released.

Following a student's withdrawal or dismissal, school records and report cards will not be given to families whose financial account is past due. Students who attend a portion of a month will be liable for the entire month of tuition. All non-refundable fees, i.e., Campus Improvement and Security Fee, Book or Class Fee are due in full, regardless of the payment plan selected or withdrawal date. Families who withdraw their student or who are dismissed will not receive a refund. The only refunds permitted will be for those families who have paid in advance more than one month of tuition for periods after the withdrawal / dismissal date.

After School Care

(Pre-school through 5th grade students)

Our After-School Care program is open until 6:00 PM every day that school is in session. This service is provided to you at a monthly rate in addition to your tuition charges. After School Care is also available at an hourly rate of \$4.50 per hour.

The following chart details the pick-up times and monthly rates:

A \$25.00 surcharge for every 15 minutes or any part thereof will be charged to any Half-Day student that is picked up after their dismissal.

Financial credit will not be given for non-attendance in the After-School Care program. Payments are made in 9 payments beginning on September 1. There is an additional charge for non-school days that the After-School Care is open. The After-School Care program closes at 6:00 p.m. Parents who pick up children after 6:00 p.m. will be charged \$1 per minute per child.

Other Fees and Services

Florida Christian School provides after school care and other extracurricular activities. Additional fees may apply for these services. Student Support Services (Discovery and Reading) Rates and Fees – these rates are in addition to the above rates.
